AIM

- The Exchange Programme intends to provide opportunities for gaining knowledge and skills for the Young Internists taking part. This is a chance to become more confident and self-reliant in professional life.
- This experience gives the Young Internists the edge in an increasingly competitive labour market and has a positive impact throughout their careers.
- This is a great opportunity to know each other better and understand the realities of other European countries.



OBJECTIVES

- The aim of this Programme is to promote short internships of one month among our European specialist training centers in Internal Medicine Units.
- The Exchange is open for Internal Medicine trainees in their third to fifth / sixth year.
- Each National Society will select their candidates with a maximum of 5 per country. EFIM supported by Amgen Europe and FDIME will sponsor 20 scholarships of €600, which number could be increased at the discretion of and sponsoring by the National Society



TRAINEE'S CRITERIA

- Speak fluent English.
- Completed at least the first two years of medical residency in Internal Medicine.
- Must have current and valid Health Insurance.
- Must have the support of their National Society.
- Should establish prior contact with the Tutor in order to obtain information about the equipment for the training period.
- The resident should write a final report of the Exchange.



CENTER'S CRITERIA

- Hospital should be able to provide an appropriate training in Internal Medicine.
- The Tutor should speak English with the resident guest.
- Clinical cases should be submitted and discussed in English.
- Help and support must be provided in finding accommodation.
- The Tutor must evaluate the final report of the trainee and submit a final evaluation to the EFIM Exchange Programme WG.
