


# European Internal Medicine Exam


An update October 2023



- Creation of high stakes high quality exam as a joint initiative between EFIM and UEMS through EBIM
- Need to harmonise postgraduate internal medicine across Europe
- Act as a desirable pan-European qualification that all Internists might aspire to attain



- Tender for a an exam provider was sent by EBIM to potential bidders in April 2023 detailing specifications and requirements
- Eight bids received by closing deadline in June
- Four bids chosen for a further presentation from their team outlining more detail (attended by UEMS)
- Two final bids were retained and presented to EFIM President and UEMS EC.
- These were LOW/APG (Assessment for Professional Growth) and RCPI (Royal College of Physicians of Ireland)
- The chosen bid was....



- Established reputation for delivering international postgraduate exams to a high standard
- Integrated exam team offering access to exam writing support, statistical analysis, establishment of relevant exam boards using expertises of RCPI.
- Opportunity for creating a long term relationship for a mutual benefit
- Already have experience of exam delivery at a European level





- Significant effort required to get this project to first Exam launch
- Small number of participants involved will need to augment team involved as project grows
- No guarantee of success
- At present no clear reason for a candidate to take a European exam in Internal Medicine
- Branding, marketing and reputation will be key factors

### NEXT STEPS



- Contractual process with UEMS/EFIM and RCPI to agree a legal framework for the working relationship around the new exam
- Terms of Reference between UEMS and EFIM concerning the financial and legal framework around EBIM
- Once above agreed then establishment of Exam Board, Question Writing and Standard Setting Groups
